# **Clinical Track Scholarly Contribution**

### Clinician-Educator

Educational administration has been the main focus of my efforts over the last 22 years, most notably as Program Director for the Family Medicine Residency Program and Executive Director of the UM Clinical Simulation Center. In the residency program, we were able to successfully expand the program through a combination of internal and federal HRSA grant funding from 28 to 33 FTEs and orchestrated very successful ACGME reaccreditations with full five-year cycles in 2007 and 2012. In the simulation center, we were able to negotiate a new budget model in 2012 with significantly increased commitments from the hospital, medical school and 13 clinical departments, helping to expand the scope of simulation in the center and expand on-unit simulation throughout the hospitals. The leadership team and I successfully launched a funded core faculty program, simulation instructor course and navigated successful ACS reaccreditation as a Comprehensive Accredited Educational Institute with a 3-year cycles (maximum cycle length allowed) in 2013, 2016 and 2019 with no citations and with five best practices identified in the most recent review. We significantly expanded CSC in 2018 with a 7000 square foot, state-of-the-art addition as well as a 700 sf 3D printing and prototyping lab, the first of it's kind at Michigan Medicine. Called the 3D Innovations Lab, this collaboration between the UM Medical and Engineering Schools develops new simulators and tools for medical and surgical training.
