First Annual Palliative Care Research Lectureship a Success

Thanks to support from a generous UM alumnus, the first Annual Palliative Care Research Lectureship was held on June 28th 2019. Dr. Jennifer Temel, Professor of Medicine from Harvard Medical School and the Clinical Director of Thoracic Oncology at Massachusetts General Hospital, was the speaker. She spoke about her cutting-edge research demonstrating the benefits of early integrated palliative care in the care of patients with lung cancer. On the basis of her research, the American Society of Clinical Oncology currently recommends referral to interdisciplinary palliative care teams that provide inpatient and outpatient care early in the course of disease, alongside active treatment of their cancer. This kind of care has been shown to improve quality of life, reduce distress, and lengthen life. Dr. Temel currently partners with the UM Palliative Care Program on a PCORI-funded study to examine the benefits of palliative care via video visits for patients with advanced lung cancer. At least sixty UM lung cancer patients will be participating in this exciting study.

Their goal is to help expand the program to improve access to timely and robust palliative care.

Two Investigators Chosen for Palliative Care Research Funding

Thanks to the generosity of the University of Michigan community, the Palliative Care Program is able to fund pilot work investigators interested in palliative care research this year. The winners of the 2018/9 "Pilot and Exploratory Projects in Palliative Care" competition are Dr. Lauren Gerlach from Psychiatry and Dr. Maria Silveira from Internal Medicine.



Dr. Gerlach plans a mixed method study to explore the challenges in managing behavioral symptoms in hospice patients with dementia. In particular, she is interested in describing how providers and caregivers balance the risks and benefits of psychotropic use for this population.



Dr. Silveira plans to examine the neurobiology of pain among patients with non small cell lung cancer. She will be collaborating with Dr. Dan Clauw and members from the Chronic Pain and Fatigue Research Center on this work.

"Clinical Issues in the Care of Older Adults: Palliative Care for Patients with Dementia and Serious Mental Illness"

Michigan Medicine and the VA Ann Arbor Geriatrics Research, Education and Clinical Center (GRECC) sponsored the conference "Clinical Issues in the Care of Older Adults: Palliative Care for Patients with Dementia and Serious Mental Illness" which happened on September 19, 2019 at the Kensington Hotel in Ann Arbor.

The program was directed by Dr. Marcos Montagnini and Dr. Susan Maixner and included national and local speakers. Some of the topics included: serious mental illness and behavioral and psychological symptoms in dementia; clinical course, outcomes and decision-making in advanced dementia; pain in dementia and serious mental illness; homelessness, serious mental illness, and aging; communication skills, decision-making capacity, caregiver distress; and dementia at the end-of-life.

Over 150 participants from multiple disciplines (Medicine, Nursing, Social Work, Psychology, etc) attended the conference. Conference evaluations demonstrated a very high level of satisfaction with the topics, speakers and the venue. It was a big success!
